

TERMS AND CONDITIONS
FOR WIN A \$300 GIFT CARD AT MARKET SQUARE DECEPTION BAY COMPETITION

1. Participation in this Promotion and information regarding redemption of any Prize forms part of these terms and conditions. Participation In this **WIN-A-\$300-GIFT-CARD -AT-MARKET-SQUARE-DECEPTION-BAY- COMPETITION** ("Promotion") is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in AEST local daylight savings time.
2. Subject to condition 3, this Promotion is only open to QLD residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
3. The following are ineligible:
 - (i) employees of the Promoter (Mintus Properties Pty Ltd ATF The Deception Bay Investment Trust trading as Market Square Deception Bay), the Tenants or Tenant's employees or any of the Promoter's agencies that are associated with the Promotion;

 - (a) Spend \$20 or more in one transaction at any Market Square Deception Bay specialty store OR \$100 or more in one transaction at Woolworths or Coles at Market Square Deception Bay dated within the Promotional Period, excluding any Ineligible Transaction. ("Qualifying Spend").
 - (b) Request and complete an entry form from the retailer, attach a valid receipt to the entry form (or if you need to retain your receipt, you must be able to present your valid receipt if you are a winner) and place in the entry barrel located near Woolworths Market Square Deception Bay.
 - (c) Customers may enter as many times as they would like per valid receipt but can only win once in this promotion. Each entry must be submitted separately and in accordance with the entry requirements. An "Ineligible Transaction" means any transaction recorded on an invalid receipt, as specified in condition 6 below.

The same purchase receipt can only be submitted once in the Promotion. The Promoter reserves the right to stamp and/or photocopy each purchase receipt submitted in the Promotion before returning them and to request to see a copy of the receipt should they be deemed a winner.

Each winner will win 1 (one) x \$300 Market Square Deception Bay Eftpos Gift Card which can be used to purchase goods and services in any store accepting Eftpos at Market Square Deception Bay.

9. The 10 provisional winners will be notified by phone and/or email after the draw. The provisional winner will only be deemed a winner once verified by the Promoter at the **Centre Management Office** during office hours **Monday – Friday 9am – 2pm**. Photo identification and proof of entry validity must be shown.

10. The Prize is subject to the standard terms and conditions of individual product and service providers. The prize, or any unused portion of the prize, are not transferable or exchangeable and cannot be taken as cash.

If for any reason a participant does not take the Prize or an element of the Prize by 5pm Thursday 23 January 2025, then the Prize or that element of the Prize will be forfeited and will not be redeemable for cash.
